  - During the examination of record provided to us by the management of the Takmil Foundation. we observed that payments were made after proper approval of Mr. Shahid Qamar, who was designated powers of approval of payments of TAKMIL FOUNDATION, by the board of TAKMIL FOUNDATION.
  - During the course of audit, we also observed that payments were not made directly from Takmil Foundation account maintained at Meezan Bank. Rather, amounts were transferred to Mr. Abdul Hanan's bank account from where all the disbursements were made subsequently. Mr. Abdul Hanan was proposed Assistant Treasurer of the foundation.
  - In our opinion and to the best of our information and according to the explanations given to us, the Receipts & Disbursements account of TAKMIL FOUNDATION conform with approved accounting standards as applicable in Pakistan, and give the information required by Societies, registered under Societies Registration Act, XXI, of 1860 in the manner so required and respectively give a true and fair view of the state of the foundation's affairs as at June 30, 2019.

Withholding tax was not deducted while making payments for various parties / vendors as

required under Income Tax Ordinance, 2001.
